

About the Program

Comunidades Activas y Seguras (Active and Safe Communities) is a joint program of UC Berkeley SafeTREC (SafeTREC) and California Walks (Cal Walks). The cohort-model program takes a community centered, cultural, and linguistic-sensitive approach to identify and address walking and biking safety concerns in Spanish-speaking communities in California. The cohort model invites 3 Spanish-speaking communities from across the state to work together, learn from each other, share resources, and support each other in building safe walking and biking communities in their respective neighborhoods.

Program Goals

- Engage Spanish-speaking communities in pedestrian and bicyclist safety discussions, empowering them to be a part of future decision-making conversations and processes;
- Connect participating communities to each other allowing them to learn from each other's advocacy efforts.

What to Expect

The program uses the Safe System Framework to increase the community's knowledge of pedestrian and bicyclist safety, identify strategies to implement in their community to improve safety for all road users, and help build rapport between residents, local officials, agency staff, coalitions, and other stakeholders.

Who is Eligible

This program is free and open to:

- Resident Groups and Coalitions
- Schools and School Districts
- Community-Based Organizations and Nonprofits
- Other groups working with Spanish-speaking populations

Program Outcomes



Safe System Overview:

Participants will learn about the Safe Systems framework, including principles, layers of protection, and strategies to eliminate fatal and serious injuries on the road.



Review of Crash Data:

Participants will review pedestrian and bicyclist crash analysis for the community's selected project area



Summary and Recommendations Report:

Detailed report identifying challenges and opportunities for improvement, as well as programmatic and infrastructure recommendations.



Community Radionovela:

Walking and biking community stories in an audio format that communities can use to support education, advocacy, or future funding application efforts.
